
Vigo, Indiana (18167)

Vigo is one of 92 [counties](#) in [Indiana](#). It is part of the [Terre Haute, IN \(MSA\)](#). Its 2005 [population](#) of 102,735 ranked 16th in the state.

PER CAPITA PERSONAL INCOME

In 2005 Vigo had a per capita personal income (PCPI) of \$27,425. This PCPI ranked 47th in the state and was 88 percent of the state average, \$31,173, and 80 percent of the national average, \$34,471. The 2005 PCPI reflected an increase of 4.0 percent from 2004. The 2004-2005 state change was 3.4 percent and the national change was 4.2 percent. In 1995 the PCPI of Vigo was \$18,726 and ranked 53rd in the state. The 1995-2005 average annual growth rate of PCPI was 3.9 percent. The average annual growth rate for the state was 3.8 percent and for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2005 Vigo had a total personal income (TPI) of \$2,817,554*. This TPI ranked 17th in the state and accounted for 1.4 percent of the state total. In 1995 the TPI of Vigo was \$2,014,617* and ranked 16th in the state. The 2005 TPI reflected an increase of 3.8 percent from 2004. The 2004-2005 state change was 4.2 percent and the national change was 5.2 percent. The 1995-2005 average annual growth rate of TPI was 3.4 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes [net earnings](#) by place of residence; [dividends, interest, and rent](#); and [personal current transfer receipts](#) received by the residents of Vigo. In 2005 net earnings accounted for 61.2 percent of TPI (compared with 62.2 in 1995); dividends, interest, and rent were 17.4 percent (compared with 20.1 in 1995); and personal current transfer receipts were 21.4 percent (compared with 17.7 in 1995). From 2004 to 2005 net earnings increased 2.6 percent; dividends, interest, and rent increased 3.3 percent; and personal current transfer receipts increased 8.0 percent. From 1995 to 2005 net earnings increased on average 3.2 percent each year; dividends, interest, and rent increased on average 2.0 percent; and personal current transfer receipts increased on average 5.4 percent.

EARNINGS BY PLACE OF WORK

[Earnings](#) of persons employed in Vigo increased from \$2,268,046* in 2004 to \$2,347,829* in 2005, an increase of 3.5 percent. The 2004-2005 state change was 3.4 percent and the national change was 5.6 percent. The average annual growth rate from the 1995 estimate of \$1,673,476* to the 2005 estimate was 3.4 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.5 percent.
