

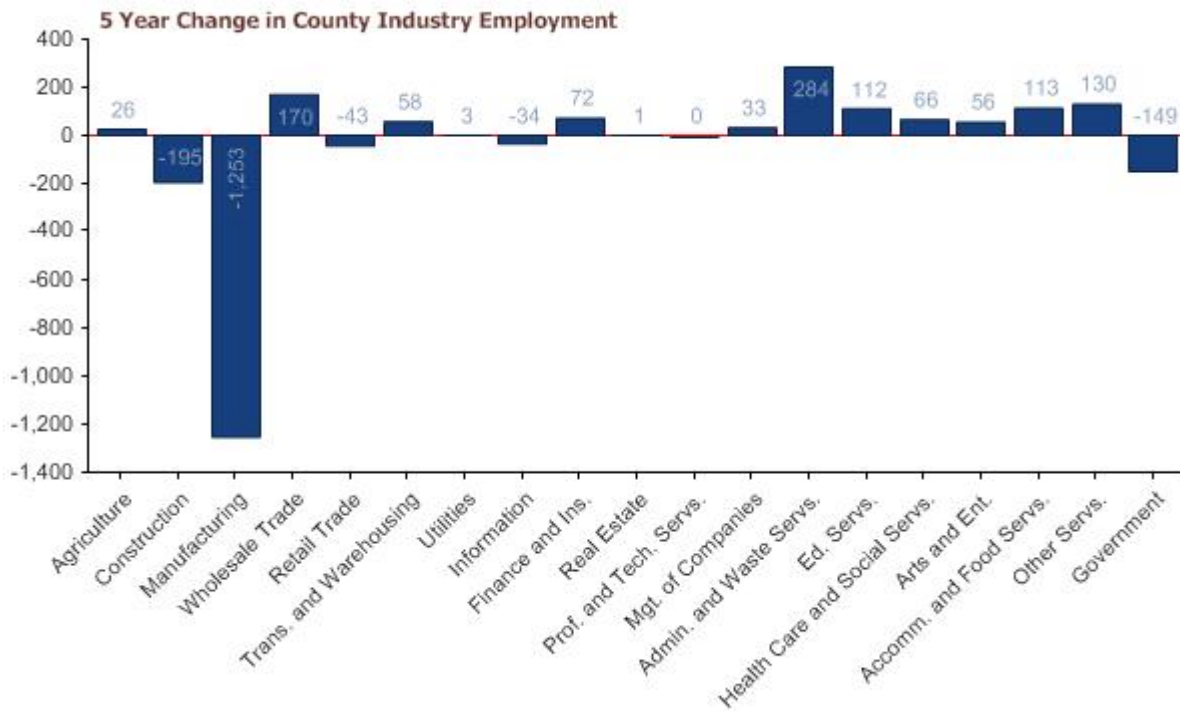
# Kosciusko County, IN Highlights

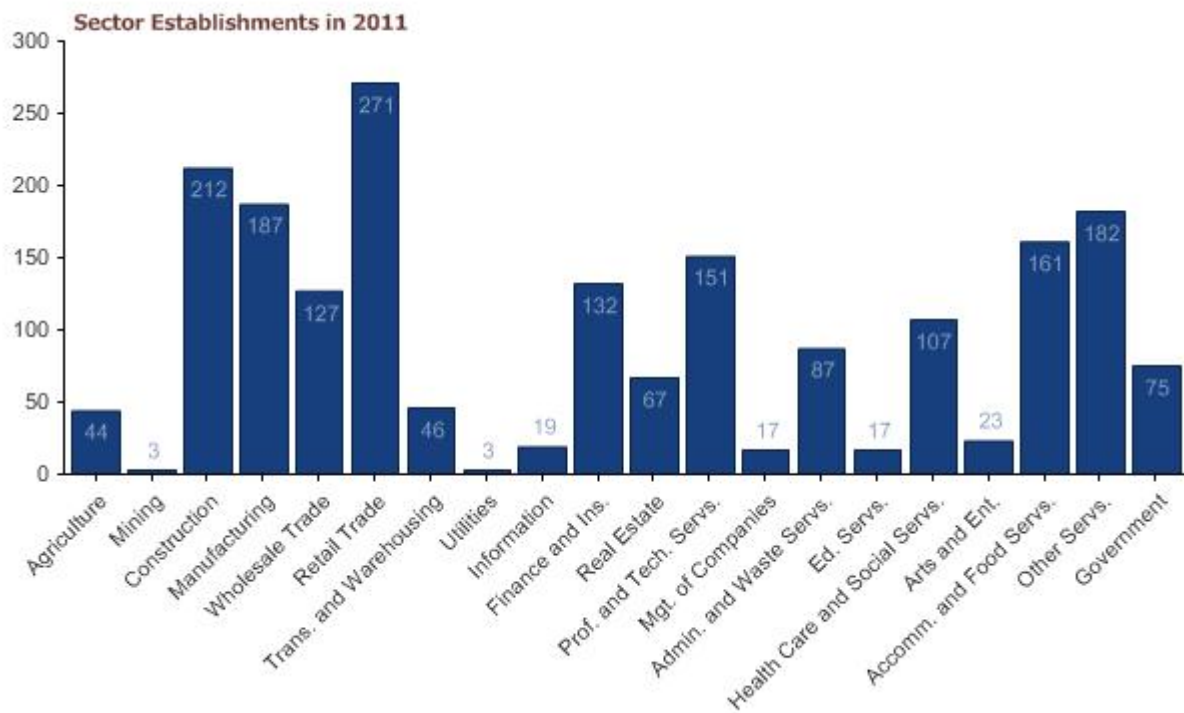
